Provide a safety net for individuals and families whose circumstances put them at risk **and who need** assistance for essential services in the areas of shelter, food, transportation and clothing.



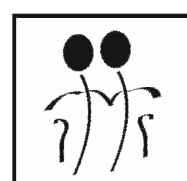
2: Child/Youth Development

Create safe environments to ensure healthy development, positive values and skills for life.



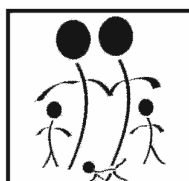
3: Older Adults

4: Strengthening Families

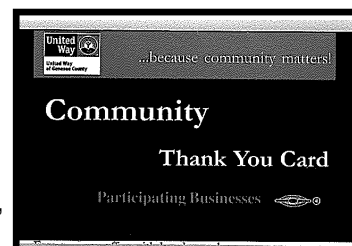
